

Maple Ridge Golf Community Tennis Court Rules

Member Acknowledgement

This form must be signed and on file at TSG before a tennis court key will be issued.

All residents should have the new keys to the Tennis Courts. If you sell your home the Tennis Court Keys and Pool Keys should be transferred to the new owner. The cost of replacement keys are \$25.00 and can be picked up at TSG. TSG is located at 4745 Armour Rd. (Grey brick house/black awnings across street from REMAX and Arey, Long and Cross, Attorneys at Law) our office telephone number is 706-653-9630.

Courts may **ONLY** be used by Maple Ridge residents (who are current with their membership dues) and their guests. Players must be prepared to identify themselves as Maple Ridge residents (or guests) if requested by a resident. Keys are not to be lent and resident must be present during all play.

Everyone must sign in when starting to play, regardless of court occupancy. Even if the courts are empty, you must put your name on the sign-up board. The sign-up board will govern playing time and court usage. The purpose of this rule is to assist in enforcing the playing time limitations on busy days.

Sign-up will be on a first-come basis. You may **ONLY** sign up for yourself and members of your family. Family time is not transferable from one family to another.

1. The courts are to be used only for tennis. The only footwear allowed on the courts is tennis shoes.
2. Players are expected to wear appropriate attire. Shirts must be worn at all times. Bathing suits are not permitted.
3. No games, play, bicycles, baby strollers, pets, glass, or food are allowed on the courts. Skateboarding and any other activities that might damage the courts are strictly forbidden.
4. Tennis ball cans and other debris should be placed in the trash receptacles provided.
5. Sitting or leaning on the nets is damaging to the nets and net straps and is strictly prohibited.
6. Spectators (including children) are not permitted on the courts. They must observe from outside the fence.
7. A player awaiting the arrival of an opponent may not hold a court vacant.
8. Rallying, warm up or practice counts towards the allotted time limits.
9. All instructors must sign an indemnity waiver before giving lessons to an owner. This may be obtained from the Management Company at the TSG office during business hours. (706) 653-9630.
10. **COURT ROTATION - TIME LIMITS:**

SINGLES - One hour maximum. Singles players should finish the game in progress and then form - doubles. However, if singles players prefer to continue their game, or if waiting players decline to play doubles, the singles players are entitled to finish their hour's play.

DOUBLES - One and one-half hours maximum. Bringing in one replacement player at a time in a doubles match **DOES NOT** extend the time limit. When the first hour and a half has elapsed, the court is to be relinquished to any waiting resident with valid Photo ID card, immediately upon completion of the **GAME** in progress.
